



Fig.2 Maximum Safe Operating Area





Fig.3 Normalized Transient Thermal Resistance vs. Pulse Width




Fig.5 Typical Output Characteristics(I)




Fig.7 Breakdown Voltage vs. Junction

Fig.8 Typical Transfer Characteristics




Fig.9 Gate Threshold Voltage vs. Junction Temperature







Fig.10 Forward Transfer Admittance vs. Drain Current




Fig.11 Drain Current Derating Curve






Fig.13 Static Drain - Source On - State Fig.14 Static Drain - Source On - State Resistance vs. Junction Temperature Resistance vs. Drain Current(I)






Fig.17 Static Drain - Source On - State Resistance vs. Drain Current(IV)







## Fig.18 Typical Capacitance vs. Drain -Source Voltage




Fig.2-1 Gate Charge Measurement Circuit






Fig.1-2 Switching Waveforms








